3. The vehicles are disposed in 'As is where is' condition. Intending purchaser should inspect the vehicles before purchase and satisfy themselves about the condition. and quality of every part and no complaint will be entertained after the disposal. No guarantee is given or implied.
4. The purchaser shall be the highest bidder. A cash deposit of 25% of the bid amount subject to a minimum of Rs.5000/- should be paid immediately the bid is knocked down. Higher percentage of deposit upto full amount may also be demanded if considered necessary. For bid amount of Rs.5000/- and less, full amount should be paid on the spot.
5. The balance of purchase price should be paid the next day at the office of the auctioneer, before 3 p.m.
